Introduction to ADN Members

This report documents the activities undertaken by the **members** of the ADN from 12 March 2019 to 31 July 2020. Members consist of ADN's Core Team, Advisory Board, Regional Coordinators and Interns.

The ADN was launched on 12 March 2019 at the 4th Summit of the Global Alliance of Disaster Research Institutes (GADRI) in Kyoto, Japan (see *Figure 1*). This first report covers the activities of 16 months. Subsequent annual reports will cover the period from 1 August to 31 July (12 months) in order to be consistent with the academic period at the University of Leicester.

The ADN's purpose is to help policy makers and practitioners make better decisions to save lives and reduce injuries from disasters to achieve sustainable development.

The ADN aims to achieve this through, although not limited to, its **six activities** (discussed below).

On 12 March 2019, the ADN's Core Team consisted of six members. This included: two founding Presidents, Dr Nibedita S. Ray-Bennett at the University of Leicester and Dr Hideyuki Shirohosita at Kansai University; the Operation's Manager, Mrs Denise Corsel at the University of Leicester; the Media and Communication Officer, Mr Matt Merry; the ADN Administrator, Mr Peter McGowran based at Kings College London (for 3 months); and an Intern, Ms Aarju Basnet based at Deakin University, Australia. The ADN Administrator was hired for three months to establish and implement the administrative process.

In February 2020, the Core Team was expanded to include Mr Jos Bal as Knowledge Exchange Officer, Ms Pangkhi Medhi as Blog Officer and Mr David Wales as Networking Consultant. However, these roles did not materialise as a result of the COVID-19 pandemic. They will be revaluated in due course.

In June 2020, the Core Team was expanded to include Ms Rwittambhara Kashyap as the ADN Administrator's for one month and Co-ordinator for the project 'North-East Network of Universities and Colleges in India' and Ms Antara Ragini Dev Sarmah as Research Coordinator for the project 'Avoidable Deaths from COVID-19'. In August 2020, Ms Shaiza Khawaja, an Intern took over the role of the ADN Administrator.

On 12 March 2019, the ADN consisted of 10 multi-disciplinary world-renowned Advisory Board Members. Since then, two additional advisors have joined the Board: Professor Daniel Ladley and Mr Steve Glovinsky (please see *Table* 1). Currently the Advisory Board consist of 12 Members from eight countries.

ADN's Activities and Achievements for 2019/2020

To achieve the ADN's purpose, six activities are undertaken:

- 1) Hosting an open space to share, discuss and disseminate international, regional, national and local news, research and innovative solutions to avoidable deaths.
- 2) Organising and facilitating conferences and seminars on avoidable deaths to foster trans-disciplinary ideas and solutions.
- 3) Promoting state and non-state collaboration through North-South, South-South and triangular cooperation in order to advance the agenda of avoidable deaths.
- 4) Advocating the agenda of mainstreaming avoidable deaths at the heart of all disaster and development activities in low-and middle-income countries.
- 5) Publishing a bi-annual newsletter.
- 6) Actively soliciting and securing private and public funds to promote the above activities.

The details of each of the activities are as follows:

Activity 1: Hosting an open space to share, discuss and disseminate international, regional, national and local news, research and innovative solutions to avoidable deaths.

To achieve this activity, the AND's Core Team is actively engaging with different platforms and widening its audience, as well as working closely with Regional Coordinators to reach out to international, national and local communities.

- The ADN has four social media outlets to disseminate international, regional, national and local news, research and innovative solutions to avoidable deaths. The media outlets are: Facebook, LinkendIn, Twitter and a dedicated website. Two to three posts per week are disseminated on these media outlets.
- On 31 July 2020, ADN had attracted approximately 370 followers from 46 countries on Facebook (of which 33% are female and 67% are male) and 320 on Twitter (of which 42% are female and 58% are male).
- On ADN's website there is a dedicated section on Resources, which consists of: i)
 Repository of COVID-19 Information; ii) ADN Newsletter; iii) ADN Publications and
 Materials; iv) Relevant Publications; v) Ongoing and Past Projects; and vi) Videos
 and Podcasts.
- The Repository of COVID-19 Information was launched on 3 April 2020 in response to the pandemic and to provide reliable information to the public. In July 2020, this Repository was viewed approximately 245 times. To increase the utility of this Repository the ADN Administrator announces an update of this page twice a week.
- On 30 April 2019, ADN officially joined the UNDRR's PreventionWeb, which is the knowledge platform for disaster risk reduction. ADN currently has a dedicated Organization Profile on PreventionWeb. Through this webpage, ADN shares news and events to the DRR community: https://www.preventionweb.net/organizations/27087/

Activity 2: Organising and facilitating conferences and seminars on avoidable deaths to foster trans-disciplinary ideas and solutions.

To achieve this activity, the AND's Core Team aims to work closely with Regional Coordinators, Advisors, and ADN's three Hubs in India, Bangladesh and Uganda.

- On 27 May 2020, the ADN Hub-Uganda was planned to be officially launched in collaboration with Makerere University and the Prime Minister's Office of Uganda. Additionally, a national workshop was to be held with key stakeholders in Uganda to identify research and enterprise themes and activities for the ADN Hub-Uganda. This official launch and workshop in Uganda were cancelled due to the COVID-19 pandemic.
- On 9 April 2020, the ADN Hub-Bangladesh was planned to be officially launched in collaboration with Dhaka University and Bangabandhu Sheikh Mujib Medical University. Additionally, a national workshop was to be held with key stakeholders in Bangladesh to identify research themes and activities for the ADN Hub-Bangladesh. This official launch and workshop in Bangladesh were cancelled due to the COVID-19 pandemic.
- On 29 and 30 March 2020, funded by Kansai University, Dr Hideyuki Shiroshita held a virtual workshop with the ADN Hub-India. The purpose of this workshop was to engage with ADN Advisors and identify research scopes for the COVID-19 outbreak in India. This led to the launch of the project 'Avoidable Deaths from COVID-19 in India' and two grant applications to WIPRO and Omidyar with the ADN Hub-India.
- On 18 December 2019, led by ADN's Regional Coordinator-India, Mr Dillip Pattanaik, the ADN Hub-India was officially launched. Ms. Neelam Mkhijani, the Country Director Childfund, and Dr. Ambika Prasad Nanda, Head of Corporate Social Responsibility (CSR), Tata Steel were the guest of honour for this event. The ADN Hub-India has a one-room office, which can accommodate up to 15 Interns/Research Fellows.
- On 8 November 2019, funded by the Leicester Institute of Advanced Studies' (LIAS) Tiger Team Funding and Global Challenge Research Fund (GCRF), Dr Nibedita Ray-Bennett organised a one-day 'Stakeholders Meeting to Raise the Visibility of ADN' at the University of Leicester.

This event was attended by two Regional Coordinators, Mr Dillip Pattanaik from India and Mrs Pamela Komujuni-Kalule from Uganda, along with two ADN Advisors, Dr Ambika Prasad Nanda from India and Mr Steve Glovinsky from the USA.

This event was also attended by a number of stakeholders, including: IPPF South Asia Region Office, Ministry of Defence, Tata Steel, National Fire Council Service Rep, Data Management Aid, Bangabandhu Skeikh Mujib Medical University – among others. This Meeting identified the number of activities that the ADN Hubs can undertake and the steps to launch an ADN Country Chapter. It was agreed that the collaboration and partnership between Leicester-and-Kansai Universities and the ADN Hubs-India, Bangladesh and Uganda would be developed and strengthened through research and enterprise activities. It was also agreed that ADN can have countless Country Chapters.

 On 7 November 2019, funded by Leicester's ESRC grant and ESRC's Impact Acceleration Account Fund, Dr Nibedita Ray-Bennet organised the Festival of Social Science on "Reproductive Health in Disasters" at the University of Leicester. The aim of this festival was to raise awareness on women's mortality and morbidity during disasters and crises, and also to showcase the outputs from the IPPFfunded research project on 'Exploring the Challenges and Opportunities around Reproductive Health in Disasters in Belkuchi, Bangladesh'.

Speakers at the Festival of Social Sciences included: Dr Ataur Rahman (International Planned Parenthood Federation-South Asia Region Office (IPPF-SAR), Bangkok), Mrs Nimisha Goswami (IPPF-SAR, New Delhi), Dr Fariha Haseen (Bangabandhu Sheikh Mujib Medical University Bangladesh), Mr Steve Glovinsky (Ex UNDP) and Dr Eva Luksaite (Keele University).

Activity 3: Promoting state and non-state collaboration through North-South, South-South and triangular cooperation in order to advance the agenda of avoidable deaths.
